The Frick Pittsburgh Board of Trustees appoints new chair and 5 new members

PITTSBURGH – The Frick Pittsburgh has elected a new chair and has appointed five new term trustees to its board, a body that includes term trustees and family trustees who are descendants of Henry Clay Frick.

Steven Pavsner, a principal at Joseph, Greenwald & Laake, P.A., has been elected as the new chair, filling the role of Robert Hernandez. Pavsner will serve in the officer position for two years.

The newly elected term trustees include Kahren Jones Arbitman, Nancy L. Barry, Tal Heppenstall, Edward Karlovich and Louis L. Testoni. Testoni was appointed as the board treasurer. The new term trustees were appointed at the end of 2024 or the start of 2025.



Steven M. Pavsner is a principal at Joseph, Greenwald & Laake, P.A., with fifty years of experience in civil litigation. He is a 1972 cum laude graduate of the School of Public and International Affairs at Princeton University, and a 1975 graduate of the Georgetown University Law Center. In addition to his practice, Pavsner has taught law at the Washington College of Law at American University and served on Princeton's Alumni Schools Committee. He was elected chair of The Frick Pittsburgh Board of Trustees in March 2025.



Kahren Jones Arbitman received both an MA and Ph.D. in art history from the University of Pittsburgh with a specialization in seventeenth-century Dutch art, more specifically, Rembrandt. She has published books, catalogues and articles on the subject. In 1985, she became the first curator-in-charge of The Frick Art Museum where she organized its first temporary exhibitions and educational programs. In 1990, Dr. Arbitman was named director of the Palmer Museum of Art at Penn State, where she oversaw the design, construction and installation of a new building by the renowned Post-Modern architect Charles W. Moore. In 1996 Dr. Arbitman was named executive director of the Cummer Museum of Art & Gardens in Jacksonville, Florida. The two exhibitions she curated of Rembrandt etchings from the Carnegie Museum of Art traveled the country, including a stop in Pittsburgh. Dr. Arbitman has been an invited speaker at museums, galleries and universities in the United States and abroad. She is delighted to be back “home” in Pittsburgh and to once again to be involved with the Frick.




Nancy L. Barry first joined the Frick board in 2013 and served in numerous roles, most significantly as treasurer. After rotating off for a year in March 2024, Barry rejoined the board in April 2025. Barry has had a successful career in public accounting, as a partner at KPMG and a shareholder at Schneider Downs, retiring in 2012. Barry is active with several nonprofits, including Calvary Episcopal Church and the Duquesne Club Charitable Foundation. Nancy has held leadership roles in the International Women's Forum of Pittsburgh and on the boards of WQED, United Way of Allegheny County, Point Park University, The Ellis School,

Duquesne Club, Manchester Bidwell Corp, FAME, Planned Parenthood of Western PA and the Arthritis Foundation of Western PA.



Tal Heppenstall currently serves as a senior advisor to UPMC. He served as executive vice president and treasurer of UPMC from 2003 through 2020 and president of UPMC Enterprises from 2014 to 2020. As president of UPMC Enterprises beginning in 2014, Heppenstall led UPMC's efforts to commercialize its managerial and healthcare expertise, particularly in the areas of information technology and life sciences.

Previously, Heppenstall served as managing director at RBC Dain Rauscher, Inc., president of PriMuni LLC, senior vice president at PNC Capital Markets and vice president at Butcher & Singer. He earned a bachelor's degree from the University of Virginia and a master's degree from Carnegie Mellon University. Heppenstall has previously served on the boards of the St. Margaret Foundation, the Manchester Bidwell Trust, the Fox Chapel Golf Club, the Women's Center and Shelter of Pittsburgh, The Western Pennsylvania Golf Association, the Pennsylvania Golf Association, the Tepper School Alumni Council, Shady Side Academy and various UPMC-affiliated entities.



Edward Karlovich is the retired executive vice president and chief financial officer of the University of Pittsburgh Medical Center (UPMC). Karlovich joined UPMC in 1990. Before joining UPMC, he was a senior manager and certified public accountant at Arthur Andersen & Co., where his client experience included public and private corporations and institutions. Karlovich has been active in several organizations over the years, including the Nemours Foundation, Pittsburgh Civic Light Opera, Senator John Heinz History Center and Community College of Allegheny County (CCAC) Foundation. He attended and received degrees from CCAC, Duquesne University and the University of Pittsburgh.



Louis L. Testoni is a senior business executive and financial expert with over 40 years of financial services experience working with global and regional companies in the public, private and not-for-profit sectors. Testoni retired as the managing partner of the Lake Erie Market of PricewaterhouseCoopers. As an executive-in-residence at the Katz Graduate School of Business, he coached and mentored master's in accounting and MBA graduates, helping them secure postgraduate career opportunities. Testoni currently serves on the Board of Trustees of the Carnegie Library System of Pittsburgh and is director emeritus for Achieving the Dream. Past board roles include the Three Rivers Chapter of the National Association of Corporate Directors, the Pittsburgh chapter and national boards of the Epilepsy Foundation, the Laurel Highlands Council of the Boy Scouts of America, and Venture Outdoors. Testoni is also a recipient of Junior Achievement's Business Hall of Fame Award in recognition

of his many years of dedicated community service activities, including more than a decade of involvement through Junior Achievement's evening and in-school programs, and as a board member. Testoni is the treasurer for The Frick Pittsburgh Board of Trustees.
